### **OLD BUSINESS**

### **NEW BUSINESS**

Kuhl Jt Irrev Trust Rezone Petition DCPREZ-2017-11110 was reviewed. This petition was approved by the Planning Commission 5-0 with a requirement that the Town of Medina Animal Restrictions be placed on the four parcels being rezoned under this petition. The farm had six density units prior to the rezone the rezoning constitutes four density units and two density units remain. Motion to approve the rezone of Lot 1 to A2(8) and lots 2, 3 and 4 to RH2 with the Town Animal Restriction on the four lots by John Hellenbrand, 2<sup>nd</sup> by Sue Zingshiem. Motion carried 4-0

A furnace maintenance agreement from Jensen Plumbing and Heating was reviewed. Maintenance was not completed on the furnaces in 2016. A motion to approve the agreement with Jensen Plumbing and Heating at a cost of \$168.00 was made by Todd Weinberger, 2<sup>nd</sup> by Sue Zingshiem. Motion carried 4-0
