Opening of Bids and Action on Sale of the 2007 Ford F 550: Clerk Jacobson reported that twenty letters were sent out to contractors and the truck was presented for sale at the Town Garage. The Town received six bids in the amounts of \$6,258.00, \$7,027.00, \$7,200.00, \$8,000.00, \$8,550.00 and \$8,725.00. Motion by Supervisor Hellenbrand to accept the bid of \$8,725.00 from Adam Griswold, 2nd by Supervisor Anderson. **Roll Call Vote:** Supervisor Anderson yes, Supervisor Hellenbrand yes, Supervisor Ward yes, Supervisor Zingshiem yes, Chairman Weinberger yes, motion carried 5-0.

Action on Resolution 2017-08 (Budget): Clerk Jacobson presented the Resolution to the Town Board outlining adjustments to the working budget and general budget. Motion by Supervisor Zingshiem to approve Resolution 2017-08, 2nd by Supervisor Hellenbrand. Roll Call Vote: Supervisor Hellenbrand yes, Supervisor Ward yes, Supervisor Zingshiem yes, Chairman Weinberger yes, Supervisor Anderson yes motion carried 5-0.

Approval of Additional Monthly Vouchers: Clerk Jacobson presented the additional vouchers to the Town Board for approval. Motion by Supervisor Ward to approve the vouchers as presented, 2nd by Chairman Weinberger. **Roll Call Vote:** Supervisor Ward yes, Supervisor Zingshiem yes, Chairman Weinberger yes, Supervisor Anderson yes, Supervisor Hellenbrand yes motion carried 5-0.

Action of Detailing of the 2017 F 550: A draft design prepared by Donna Hellenbrand showing the door detailing was presented to the Town Board at a cost of \$200.00. Motion by Supervisor Zingshiem to approve the proposal from Donna Hellenbrand at a cost of \$200.00, 2nd by Supervisor Anderson. Roll Call Vote: Supervisor Zingshiem yes, Chairman Weinberger yes, Supervisor Anderson (absent) correction to yes, Supervisor Hellenbrand yes, Supervisor Ward yes, motion carried 5-0.

Action on Purchase of Tool Box for the 2017 F 550: Information was presented by Jim Hellenbrand and Chairman Weinberger on a proposal to have a tool box designed for the 2017 F 550 by Steve's Car and Truck Service. The tool box would be designed to go under the dump box behind the passenger door. It would be designed to fit the area and be large enough to hold chain saws. The estimated cost would be under \$1,000.00. Motion by Supervisor Zingshiem to approve the purchase of the tool box designed by Steve's Car and Truck Service not to exceed \$1,000.00, 2nd by Supervisor Hellenbrand. **Roll Call Vote:** Chairman Weinberger Abstain, Supervisor Anderson yes, Supervisor Hellenbrand yes, Supervisor Ward yes, Supervisor Zingshiem yes, motion carried 4-0, Chairman Weinberger abstained.
