OLD BUSINESS:

Discussion on Weight Limits – **Follow Up**: Patrolman Jim Hellenbrand reported that the 10-ton weight limit signs have been taken down, except for E Medina Rd. He said they would keep an eye on the roads in case we need the signs need to be put up again. Hellenbrand said he would put up extra signs on E Medina.

Discuss/Action on Final Copy Clerk Job Description: Chairman Weinberger went through the Clerk Job Description page by page and highlighted changes and deletions that were made. A motion to approve the Clerk Job Description as presented was made by Supervisor Ward, 2nd by Supervisor Hellenbrand, motion carried 5-0.

Discuss/Action on 2018 Financial Reports: Clerk Jordan gave a lengthy explanation on the 2018 Financial Reports. Jordan stated that the software currently being utilized is not set up to do Fund Accounting. She will look into other options for accounting software and will bring the information to a future meeting. A motion to accept the 2018 Financial Reports as presented was made by Supervisor Zingshiem, 2nd by Supervisor Braithwaite, Roll Call Vote, motion carried 5-0.

Discuss/Action on Building a Berm: Patrolman Hellenbrand received a quote from Dunneisen Excavating. They suggested bringing in the extra dirt needed from the ditches in the Town that need to be cleaned out. The quote also included needed silt socks and a Culvert. The total quote was \$5500.

A motion to contract with Dunneisen to clean the Ditches – Berlin Rd Dirt, not to exceed \$3500, was made by Supervisor Zingshiem, 2nd by Supervisor Hellenbrand, motion carried 5-0.
