Discuss/Action on Awarding Road Bids:

The Town Board offered 3 Options to Contractors for Canal Road, 4 Options for E Medina Road and 1 Option for Berlin Road. Three Contractors submitted bids for the 3 Roads.

Canal Road: Scott Construction submitted bids for all 3 Options, Tri-County Paving submitted bids for 2 of the 3 Options and Wolf Paving submitted bids for 2 of the 3 Options. Motion by Supervisor Ward to Award **Scott Construction** the bid for Option 1; Wedge – 66 ton @ \$96.50 = \$6,369.00, Double Seal - \$21,331.00, for a total of \$27,700.00 and to also Award **Scott Construction** Option 3; Adding an additional driveway apron at 464 Canal Road for \$1,352.00; which will be paid for by Dustin Wilke; 2nd by Supervisor Zingshiem, Roll Call Vote 5-0, motion carried.

E Medina Road: Scott Construction submitted bids for all 4 Options, Tri-County Paving submitted bids for 3 of the 4 Options and Wolf Paving submitted 3 of the 4 Options. Motion by Chairman Weinberger to Award **Scott Construction** the bid for Option 3; Cut out, improve base = \$5,000.00, Wedge and Patch —

66 ton @ \$96.50 = \$6,369.00 and Double Seal = \$7,011.00, for a total of \$18,380.00; 2^{nd} by Supervisor Hellenbrand, Roll Call Vote 5-0, motion carried.

Berlin Road: Scott Construction, Tri-County Paving and Wolf Paving; all submitted a bid for the Option available. Motion by Supervisor Hellenbrand to Award **Scott Construction** the bid; 3 inch Cold Mix -10 ton @ \$335.00 = \$3,350.00 for the total; 2^{nd} by Supervisor Ward, Roll Call Vote 5-0, motion carried.

Discuss/Action on Public Safety Building A/C System Replacement:

Supervisor Hellenbrand explained the entire A/C System needs to be replaced. Hellenbrand submitted a proposed bid from Cardinal Heating & Air Conditioning for \$39,921.00, which includes a one week build time. Motion by Chairman Weinberger to approve a new A/C System, not to exceed \$13,248.00 for the Town of Medina's portion, 2nd by Supervisor Ward, Roll Call Vote 5-0, motion carried.

Discuss/Action on Resolution 2019-05:

Motion to Approve Resolution 2019-05; Medina Town Board to Propose the Purchase and Financing of the Property located at 5536 Missouri Road in the Town of Medina for the offered price of \$285,000.00 less \$1,000.00 earnest money, and is contingent upon the Town of Medina Electors Authorization, by Supervisor Braithwaite, 2nd by Chairman Weinberger, Roll Call Vote 5-0, motion carried.

Discuss/Action on Resolution 2019-06:

Motion to Approve Resolution 2019-06; Medina Town Board to Propose the Financing of Additional Funds for the Property located at 5536 Missouri Road, in the Amount of \$65,000.00 for Immediate and Future Improvements to Existing Structures; contingent upon the Town of Medina Electors Authorization, by Supervisor Braithwaite, 2nd by Supervisor Ward, Roll Call Vote 5-0, motion carried.
