- 1. To consider the adoption of a resolution by the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under s. 66.0602 of Wis. Statutes, specifically a proposed tax levy which would exceed the allowable town tax levy for 2020 payable 2021 \$48,906.94
- 2. To approve the total highway expenditures for 2021 pursuant to s. 82.03(2)(a) of Wis. Statutes;
- 3. To approve the 2020 total town tax levy to be collected in 2021 pursuant to s. 60.10(1)(a) of Wis. Statutes
