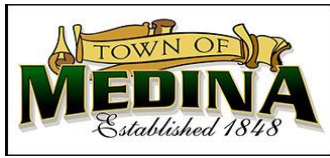

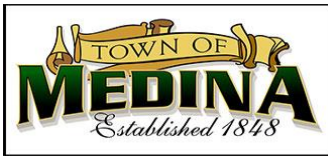
The Pledge of Allegiance was cited by those in attendance.

Motion by John Hellenbrand to Approve Tax Levy Resolution 2020-06, 2<sup>nd</sup> by Tammy Jordan; Motion carried 10-0, Hand Count 10 Aye, 0 Nay, 3 Abstentions (not qualified to vote)

To approve the total highway expenditures for 2021 pursuant to s. 82.03(2)(a) of Wis. Statutes. Motion by Leaota Braithwaite, 2<sup>nd</sup> by John Hellenbrand, Motion carried 10-0, Hand Count 10 Aye, 0 Nay, 3 Abstentions (not qualified to vote).

To approve the 2020 total town tax levy to be collected in 2021 pursuant to s. 60.10(1)(a) of Wis. Statutes. Motion by Sue Zingshiem, 2<sup>nd</sup> by Katherine Braithwaite, Motion carried 10-0, Hand Count 10 Aye, 0 Nay, 3 Abstentions (not qualified to vote).

Motion by Tammy Jordan to adjourn, 2<sup>nd</sup> by Leaota Braithwaite. Motion carried unanimously. Adjourned 6:21 PM
