Patrolman Jim Hellenbrand submitted a written report for the Highway department, which included the Feenstra Road project is complete, fixed some shoulders with gravel and by the end of the upper driveways on Feenstra Road, placed 25 mph speed limit signs on Feenstra Road, placed curve markers on Conner Drive, Oak Park culvert is done, put new batteries in the F550, culvert was ordered for Conner Drive, and hauled dirt in by Box Elder Road bridge.

Supervisor Ward reported for EMS/Fire; Supervisor Hellenbrand was out of town, approved up to \$15,000.00 for a generator, District meeting will be held in October, and Chairman Weinberger will attend a EMS service meeting in the City of Sun Prairie on September 15th.
