## RESOLUTION 2022-1 TOWN OF MEDINA FEE SCHEDULE

**WHEREAS**, the TOWN OF MEDINA is duly authorized to charge for various functions, services and permits;

**WHEREAS**, the exact amount of such fees is and shall be determined by State Statute, Town Ordinance, or Resolutions of the Town Board, as may be amended from time to time: and

**WHEREAS**, the Town Board has concluded that, for reference purposes, it is useful to have a single schedule summarizing those fees: and

**WHEREAS**, the Town Board originally adopted Resolutions 2000-01 and 2018-02 and 2020-01 as the Town Fee Schedule and periodically updated that Fee Schedule:

**NOW, Therefore**, the Town Board does hereby resolve that this resolution supersedes Resolution 2020-01 and all updates to that resolution and establishes the following as a summary of current fees as of January 18, 2021.

### A) Public Works

- 1) Rates for public works equipment as detailed in the Wisconsin Department of Transportation Bureau of Highway Maintenance Classified Equipment
- 2) Employee labor cost current wage plus Social Security/Medicare plus Employee Trust Fund cost
- 3) Administrative Fee of \$25.00
- 4) Materials at cost of those materials
- 5) Contractor costs to repair municipal property or roads
- 6) Any work being done in Town Road Right of Way - Permits of \$ 250.00, non-refundable
