The Board approved, without objection, to re-order the agenda.

Update on BIL Funding: Chairman Weinberger shared that a plan for road work on Missouri Rd, from Box Elder to Sherman, was submitted for BIL Funding. This would be for a full reconstruction, with an estimate of \$647,800; of which the Town would be responsible for approximately \$130,000. The road project for LRIP Funding was approved for Box Elder; Hwy 19 to Missouri Rd, with the Town share at \$255,000. Bridge aid was also approved the the Box Elder Bridge of \$74,500 being the Town's share.

Referendum Results and Next Steps: Chairman Weinberger shared the Referendum Results were a majority voted "No". The next steps suggested by Weinberger, are to establish a new Committee to look at alternative ideas for building a new town hall, updating current town hall if allowable, and to gather information to bring back to the Town Board.

Motion to terminate pursuit of new facility, regarding the referendum and to cancel the Special Town Elector Meeting on April 20, 2022 by Chairman Weinberger, 2<sup>nd</sup> by Supervisor Ward; Roll Call Vote, motion carried 5-0.
