Awarding of the contracts will be completed at the Town Board Meeting on May 11th, 2022 beginning at 6:00 PM.

All asphalt bids shall be submitted on a per ton cost basis.

All Sealcoating bids shall be submitted on a per square yard cost basis.

Provide separate bid for sweeping on Maple Heights.

All crack fill bids shall be separate from seal coat applications.

All bids shall include coverage of the full width of the road.

All materials shall meet DOT specifications.

Work shall be completed by August 31, 2022. A fine of \$250 will be deducted from the contracted amount for each day of non-completion after that date unless prior approval by the Town Board.

The Town Board will consider all bids but reserves the right to reject any or all bids.
